EGH's Day Center provides a safe space for low-income, homeless, at-risk women to receive support and access to basic services, including clean clothes, food, hygiene, internet communication, counseling, and referrals to shelters or support services. EGH also educates and empowers homeless women by offering individual case management through our staff and a pro-bono Care Team of community professionals. Each woman who enters the Day Center fills out an intake questionnaire. This is followed by a 1:1 interview with a staff person who helps the client identify specific goals and arranges for either a referral to applicable community resources or to the appropriate specialist on our Care Team. In 2014, our Day Center served 619 women for a total of 8412 visits.

EGH's Transitional House affords eight single, homeless adult women a place to live for up to 2 years. This environment prepares women to live self-sustaining, independent, and safe lives. EGH works to ensure that 100 percent of the women who leave the transitional house will never be homeless again. In order to achieve this goal, EGH trains its clients to improve their life skills in four critical areas: attaining permanent housing, building financial stability, maintaining social connections, and developing interpersonal skills. Residents participate in educational and training sessions such as budgeting, communication skills, and community resource awareness, as well as gain essential practical experience through volunteering or employment opportunities.
